#### **Privileges**

- Fly the club plane as schedule allows.
- Fly on whole day trips as schedule allows without approval of a club officer.
- Use the club's online calendar for scheduling on first come first serve bases.
- Attend monthly club meetings with speaking rights.
- Receive a refund for your club fees paid in advance, in case the club gets dissolved, for remaining months.

#### Responsibilities

- Online schedule is to be used at all times and club's bylaws must be read.
- Over night trips are to be approved by a club officer.
- Immediate notification of the club with any and all problems with the plane.
- Pilot in command is responsible for all damage incurred while in command, up to, but not limited to, deductible of insurance policy. On a case by case bases, club discretion may apply.

- Club must be notified in writing, 30 days prior to canceling membership. Otherwise the next month fee is expected to be paid in full. Read Club's bylaws.
- Fuel up both tanks if more than .5 hours are flown, before parking in hanger.
- Any landing fees are the pilot's responsibility.
- The difference of a higher fuel charge, at another airport other than P34, is paid by the pilot.
- Without a proper fuel receipt there will not be a refund for the portion the fuel would cost at the home base airport P34.
- Plane to be hangered in clean and presentable way, all seat belts in order, head sets neatly placed where you found them, all trash removed, flight log filled out and in glove compartment.
- Airplane is put away with cleaned windows leading edges of wings, wing struts, main gear, nose gear and propeller.
- All cleaning instructions must be followed.
- If an updated copy of this application is produced you will adhere to all the changes.

The club reserves the right to slightly adjust the hourly rate depending on fuel price at our home base airport P34, at any time.

#### Fee Schedule

#### **Pilot**

- \$ 850.00/year paid in advance 1<sup>st</sup> year. Following years \$350.00/year
- \$ 80.00/hour (wet)
- \$ 80.00/monthly due
- \$ 750.00 Refundable deposit. 4 hours billed/year if you fly or not, quarterly.

**Student Pilot** (All flight training and solo flight before receiving your pilots license)

- \$ 850.00/year paid in advance 1<sup>st</sup> year. Following years \$350.00/year.
- \$ 89.00/hour (wet)
- \$ 80.00/monthly due
- \$ 750.00 Refundable deposit. 4 hours billed/year if you fly or not, quarterly.
